Directions to Hasting's Island Hunting Preserve:

From San Francisco: Take I-80 East; Turn RIGHT onto CA-12 toward Rio Vista; Turn LEFT onto CA-113 N; Turn RIGHT onto HASTINGS RD (Portions unpaved); HASTINGS RD becomes HASTINGS ISLAND RD.

From Sacramento: Take US 50 South; US-50 W / CAPITAL CITY FWY becomes I-80 W; Take the CA-113 exit toward DIXON; Stay STRAIGHT to go onto CURREY RD.; Merge onto CA-113 S.; Turn SLIGHT LEFT onto HASTINGS RD (Portions unpaved); HASTINGS RD becomes HASTINGS ISLAND RD.

All speed limits on the island must be observed. Hastings Island requires visitors/participants to check in and out at the clubhouse.

Weimaraners that have disqualifying faults (as listed in the current standard for the breed) shall be eligible to compete for and receive ratings provided they are spayed or neutered. *PRIOR to being entered* in a ratings test, Weimaraners with disqualifying faults must be certified by the National Office as being spayed or neutered and receive a DQF Number. All weimaraners with AKC ILP/PAL numbers are allowed to participate without applying to the National Office.
