#### **Directions to Hasting's Island Hunting Preserve:**

**From San Francisco**: Take I-80 East; Turn RIGHT onto CA-12 toward Rio Vista; Turn LEFT onto CA-113 N; Turn RIGHT onto HASTINGS RD (Portions unpaved); HASTINGS RD becomes HASTINGS ISLAND RD.

**From Sacramento**: Take US 50 South; US-50 W / CAPITAL CITY FWY becomes I-80 W; Take the CA-113 exit toward DIXON; Stay STRAIGHT to go onto CURREY RD.; Merge onto CA-113 S.; Turn SLIGHT LEFT onto HASTINGS RD (Portions unpaved); HASTINGS RD becomes HASTINGS ISLAND RD.

All Weimaraners with AKC ILP/PAL numbers are allowed to participate without applying to the National Office.
